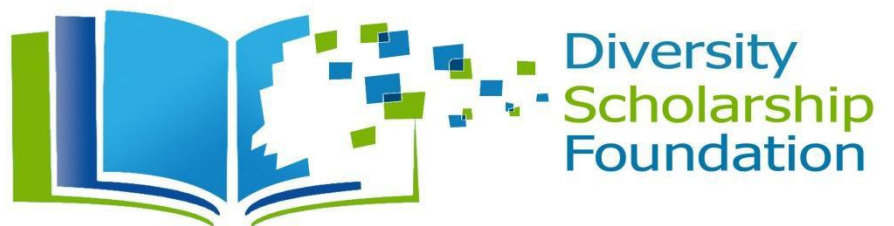

## Scholarship Opportunities

Since 2006, the Diversity Scholarship Foundation, NFP has provided scholarships and opportunities to law students of diverse backgrounds. The annual Unity Award Gala serves as the main fundraiser for these scholarships. Each year, our legal



community has joined together to raise enough funds to provide an increasing number of scholarships. The scholarships we offer run the gamut of those students interested in public service upon graduation to those who are leaders and achievers in the legal community. Our scholarships are open to all who are dedicated to having our legal community represent the community at large. **This year we will be awarding 21 scholarships.**

## Promoting Diversity in the Legal Community
